# PLEASE READ THIS PROSPECTUS CAREFULLY

### ARTWORK REQUIREMENTS:

- 1. Artists must be 18 years or older.
- 2. Each artist may enter only one (1) painting.
- 3. All entries must have been created after 1/1/2022
- Paintings previously exhibited in any National or International Open Exhibits, including NWS Member Exhibits, are <u>not</u> eligible.
- 5. Painting must be watermedia paintings on natural or synthetic paper. Yupo, Aquabord and Claybord must be framed No stretched canvas or canvas board. Collage may be used but aqueous medium must constitute 80% or more of the work. All collage materials must be original designs executed on watermedia paper by the artist.
- 6. Other media, if used, must be in conjunction with watermedia, which must be dominant.
- 7. Digital media, photography, prints, reproductions, diptychs or triptychs are not permitted.
- 8. Your entry must be original and not derived from published images; artist's own idea, composition, and design (not computer generated), nor done in a class. Photo reference material must have been taken by you.
- 9. Paintings must be at least 5"x7" minimum. Maximum size is 40" on the longest dimension.
- 10. All accepted artists are required to ship their paintings.

**SUBMISSION:** Paintings can only be submitted online via CaFE'. If you don't already have an account, click <u>HERE</u> to create your free account. (Café Specs: File type - jpg 1200 pixels or greater on longest side, max 5MB). Images must be cropped to exclude mat, frame, and any background.

## FEES, SALES, & LIABILITY:

- The <u>non-refundable</u> entry fee is \$45 for NWS members and \$70 for non-members. Members must go to the MEMBERS ONLY page of the NWS website to get the discount code for members.
- Non-members may join as Associate Members by paying \$60 annual dues BEFORE entering. Membership can be paid at <u>https://www.nationalwatercolorsociety.org</u>
- All paintings must be for sale and there will be no price changes after entry. Your price should reflect the cost of the frame. NWS is responsible for all sales and will retain 30% commission. NWS is due 30% commission on "presold" paintings - sold before or during the exhibition.
- Purchase Award recipients must ship framed painting to donor (price accordingly).
- Attention International Artists: NWS wants to make sure you receive all proceeds, including awards. NWS will provide all necessary documents and tax forms.
- NWS and it's representatives will take the utmost care, but are not responsible for misrepresentation.
- Unclaimed awards will be forfeited after 12/1/2024.

# Agreement / Conditions & Rules

**Please read carefully:** By entering this exhibition, the artist agrees that they have read and will abide by all the rules. Submission of this image shall constitute an Agreement on the part of the artist to comply with the conditions set forth in this Prospectus, including the following:

- Overpayment of any fee will be considered a donation and will not be refunded.
- Original painting must match the submitted image.
- Permission is granted to reproduce the painting in promotion of the exhibition and to use this image for educational and publicity purposes.
- Accepted paintings may not be displayed or offered for sale in another sale or any other exhibition, competition, or gallery, neither virtual nor physical, during this exhibition (October 1 -November 3, 2024).
- Failure to meet ANY of the conditions will result in disqualification of your entry and the ineligibility to enter future NWS exhibitions for a minimum of two (2) years and the forfeiture of any awards.

### NWS SIGNATURE STATUS INFORMATION

NWS Associate members and non-members who are juried into this exhibition shall be invited to apply for Signature Membership. NWS By-Laws, Article III, Section 3.01 (A) (B) state that:

- Associate & Non-members shall submit three (3) additional paintings to be viewed by the Jury of Selection, at a time to be set by the Board of Directors. The Jurors will make the decisions regarding granting Signature Membership.
- Associates & Non-members shall submit a signed application for Signature Membership providing evidence of 3 (three) paintings exhibited in NWS International Open Exhibitions. Acceptance in NWS Member Exhibitions or any other NWS Exhibitions shall not be considered for such application.

Tutorial for Signature Applicants will be on Tues, Jul 9th via Zoom.
